## ORDER

New Delhi, the---- , 2022

- S.O.———(E).- In exercise of the powers conferred by sub-sections (1) and (2) of section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the central Government, after consulting the Bureau of Indian Standards, is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following order, namely:-
  - Short title and commencement.- (1) This order may be called Household and similar Electrical Appliances (Quality Control) Order, 2023.
    - (2) It shall come into force with effect from date.....
  - 2. Compulsory use of Standard Mark.- Goods or articles specified in the column (1) of the Table shall conform to the corresponding Indian Standard specified in column (2) of the said Table and shall bear the Standard Mark under a license from the Bureau as per Scheme-1 of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018:

Provided that nothing in this order shall apply to goods or articles meant for export.

Certification and enforcement authority.- The Bureau shall be the certifying and enforcing authority for the goods or articles specified in the column (1) of the said Table.
